Our Sarong Queen is of course our favorite doll, Terri Lee. She appears in the first Lincoln Nebraska Fashion Parade on page 13 wearing a Sarong and Bonnet. The

titled "In The Good Old Summer Time" and explains "for sunbathing or even taking a dip in the water, I wear my beautiful sarong." I am not sure Violet Gradwohl was inspired by Dorothy Lamour but the thought behind this outfit compliments Vi's love of the exotic. Since Terri Lee is a toddler doll Vi had to create an appropriate costume for her sarong. Because sarongs for ladies became popular after the movie "Jungle Princess"

SARONG SUNSUIT and SUNBON-NET — the gayest ever green and white stripes. Terri loves the perky, wide sarong bottom, and the cool bra top. Both tie with satin ribbons. The sunbonnet looks adorable on Terri. Complete, \$4.25. SWIM SUIT and BEACH COAT (not illustrated) Complete \$1.95.

The sarong and sunbonnet is one

of three sets of clothing which can be purchased by ordering from "The Toy Shelf." The prices are postpaid.

The write up says "My goodness. I nearly forgot my new sarong sunsuit and sunbonnet! It is made of green and white striped cotton. It has a bra top that ties with white satin ribbons. My sunbonnet matches my sunsuit. It ties under my chin with white satin ribbons."

The sarong sunsuit and sunbonnet is also offered as a "Play set" on page 21 of the November 1948 Junior Magazine.

I have recently found a lady with a fabulous childhood collection of Terri Lee items who has this green and white loopy tagged sarong and sunbonnet.





Susan Girardot, an eBay seller, has a Terri Lee doll in a loopy tagged sarong outfit made with a different fabric for sale. This outfit is definitely more showy. A California friend also has this sarong.

According to the number 2 Lincoln Nebraska Fashion Parade the retail price for "Terri in Sarong and Bonnet" was \$9.95 and the Sarong and bonnet alone was \$1.95. If you look closely you will see that the sunsuit and sunbonnet set in Junior







appears to be more like the one pictured and there is also a burgundy and aqua geometric print.

Magazine was offered at a whopping \$4.25 which included postage but is still an exceptionally inflated price?

Terri Lee's Nebraska era ended in December 1951 and Violet Gradwohl moved the company to Apple Valley California in 1952. This picture appears on page 11 of the July 1952 Monthly magazine. "This is my Apple Valley Sun Suit." It was printed in green ink and so the color is undetermined but it appears to be an animal print. Here is Sue Munsell's navy and aqua animal version.

The burgundy and aqua version





The "Apple Valley sunsuit" appeared in 1952 and so did this ad in the Montgomery Ward's Christmas Book which shows the most popular fabric used for Terri's sarongs. This is probably a Lincoln Nebraska doll since Violet had just moved to Apple Valley and it is doubtful that she could have had an Apple Valley doll ready in time for the Christmas Book. The ad appears on page 118 and states "Terri Lee" modeled from a real 2 year old, All Plastic, practically Head turns unbreakable. and movable arms and legs, painted eyes. Raysheen hair can be washed, set,

"permanent waved." Printed cotton "Sarong and bonnet", socks, shoes. Booklet tells about "Terri" how to join her "Friendship Club." wt 2 lbs 6 oz. abt. 17 1/2 inches tall. \$12.45. This fabric came in many different colors, some of which are shown here in Sue Munsell's picture.

When I go golfing or bicycling, I wear pedal pushers, and for tennis, I wear tennis shorts and a sport shirt. I have a sarong, too, with a wide bonnet to match. It's wonderfully cool on hot days. Mother encourages me to get plenty of sunshine, because she says it's very good for little girls, and whenever I go outside for a sun tan, I wear my sun suit. Jerri has a nice sun suit, too.

3520C Pedal Pushers and Shirt 3520D Shorts and Shirt 3520G Sarong and Bonnet 3510C Sun Suit Valley sun suit", and the animal fabric in burgundy in aqua.

The new title is Summer Playtime and the new description is "I have a sarong, too, with a wide bonnet to match. It's wonderfully cool on hot days."

Welcome to the California desert! Number 520G Terri in Sarong and Bonnet is now listed for \$12.95 and 3520G Sarong and Bonnet is still \$1.95.

The geometric fabric comes in brown and green also.

Surely the Sarong and Bonnet outfit was one of the most popular outfits of its time and yet it disappeared after the First Apple Valley Fashion Parade. Perhaps the price was too reasonable for the amount of sewing necessary to complete the three separate pieces. There were no sarong outfits for Tiny Terri Lee.

The fabric for the sarong on the right was also used for calypso outfits. The flower girl below looks to be fresh from the garden.





The sarong and bonnet at the right is the only pique outfit that I have found. This fabric was also used for Terri Lee beach coats.



At the Queen of dolls Terri Lee Convention in 2016 there was a competition category of Sarongs which produced some fabulous entries including 4 blue ribbons. Wanda Houck won a Best of Show ribbon with her pink sarong outfit.



Wanda tells me that this pink Sarong and Bonnet outfit has a loopy tag and that she purchased many years ago at a premium price. I believe there were more fabrics used for the sarong than any other Terri Lee outfit.

RIBBON HEAD BANDS

I have often wondered about a half dozen satin ribbon headbands in my collection and what they were for. A headband, a waistband: the big question...What are they?

As my research progressed on the Snoods and Tip-Top I stumbled upon the May 1954 Monthly Magazine and now an eBay item showing a Connie Lynn with a Ribbon Head Band appears.

Dimensions: 3.5 inches long -7 inches total circumference

In my opinion it would fit a CL head quite nicely OR a Terri Lee.



I acquired these 20-plus years ago when purchasing TL wigs, slips, panties and Frontier hats from Bea at Hobby City, Anaheim, CA. She had let Jerry (my husband) and me go into her storage shed and gather any and all TL items I could locate. Dumb me that I didn't take it all when I had a chance, I wanted to leave some things for others. One ribbon band has a cloth flower the same as what is on some formals.



I have 6 pinks, 1 yellow and the purple with flower attached. All I know is that in our Terri Lee collecting it has paid to not throw out odd accessories.

We have factory verification the head band was used on a Terri Lee. The eyelet Garden Party dress is perfect with the Ribbon Headband Accessory.

May 1954 Monthly Magazine

No factory documentation can be located to validate this could have been used on Connie Lynn, but it makes sense. Babies have long worn a headband denoting sex.

TL 1ST MONKEY PRINT AND 1950S CHILDREN'S CLOTHES

Take a look at an old photo taken by **Lynn Kopatich**'s mother in the mid-1950s. Does anything look familiar to you?

Yes!! Monkey print!! It's difficult to tell the color of the famous "monkey print" fabric from this black and white picture, but Lynn "just sees pink" when she remembers the dress. She did not have many pink clothes and feels that this one probably had a light pink background and some trim in a stronger hue of pink. The top of the dress is hidden by the jacket and time, but Lynn says:





As far as the skirt part of the dress, it did have tiers but I can't tell you how many - just a few, two or three, I think. The bottom tier evidently had some loose stitching because I remember while wearing the dress, half the bottom tier fell away from the rest of the dress when I caught it on something. My mother must have repaired it after we came home. This was my favorite dress and I wish my mother would have saved more of my clothing. She probably gave it to one of my cousins.

Lynn's family lived on a farm near Mediapolis, Iowa. Her mother shopped at The Town Shop which did not sell the TL doll.

There was a women and girl's dress shop in our small town and I believe the dress was purchased there. The odd thing to me is that I don't know that any other girl from town had

the same dress which would not have been unusual: small town, one small dress shop, lots of mothers shopped there, so duplication was not unheard of.

So!!! It turns out that Terri and Jerri Lee were not the only ones...

Composition Bonnie Lou in Original Box 1946-1947

Look what recently surfaced on eBay! A *composition Bonnie Lou with box* and in original clothing: white organdy dress, green raincoat and hat, original daisy, shoes and socks, one of which is still tied in its original bow. Bonnie's box is the high-sided porthole box, the first one we've ever seen in a solid color, a pink or magenta.

Box label is of special interest. It has the topknot logo, but does not yet have the location of company.

In the following pages, taken from my chapter, *TL MIB*, an inventory of all the TL boxes we've found so far, notice...

- 1) "Ladies of Fashion" paper and "Toddler" label without the topknot logo
- 2) "Art Deco" paper; label now includes the topknot logo
- Red, white, black plaid paper, topknot logo, with MIB compo doll purchased from the 1946 Montgomery Ward catalogue.
- 4) Red and white plaid paper; label now includes manufacturing location, "Lincoln, Nebraska," and a stock number, 170, which was the basic number for TL in snowsuit.



Written on the Black compo box label above is the number 9.17. Is this unlikely figure a price or what? The earliest wholesale price list shows price of the dolls in Rain Coat and Hat @ 96.00 Doz. The second list, a retail price list, shows assorted TL \$16.50 each.

"LADIES of FASHION" paper & "TODDLER" LABEL.

The first Terri Lee company boxes were "HIGH-SIDED," that is, 1" taller and 1" narrower.

This is the first one to surface with the "LADIES of FASHION" paper in red, yellow, blue & chartreuse & green. Incredibly, the box still had a composition doll in it. The hair is auburn mannequin.


The label on this "LADIES of FASHION" box has no head topknot logo. Therefore. must this box any other precede early "HIGH-SIDED" Terri Lee box, which does have the topknot head logo.

COMPOSITION TERRI LEE IN HIGH-SIDED BOX WITH ART DECO PAPER

The earliest dolls Terri Lee Company dolls were sold in high-sided boxes (1" taller and 1" narrower) with distinctive porthole lids. Consult your copy of "Terri Lee Mint-in-Box," the 40-page color chapter I wrote covering all TL Co. boxes (New Collectors: you can order one from me: ratherpat@vom.com or 707 996-8300). The label below is identical to the one used at Christmas, 1946. The paper, however, we had not seen before. Always something new in TerriLeeLand!









1946 COMPOSITION TERRI LEE



Incredible, isn't it, that such a mint composition Terri Lee should still exist! This one is in original HIGH box was bought Christmas '46, from the Montgomery Ward catalogue, (BELOW LEFT), the first year Terri Lee was on the market. Notice that the label has the "topknot" logo, but no address, making it, therefore, the *second version*. The doll's original owner did not care for compo Terri. Terri spent three years in her box until in 1949 her owner decided to take pictures of all of her dolls (Close Up LEFT MID)& store them away. 50

years later she sold Terri Lee, unplayed with & in her complete outfit with original wrist tag & flower. Even though scarcely ever out of her box, Terri suffers from lip paint that has partially flaked away. Note "porthole" lid, & the unique paper covering box.







EARLY PAINTED PLASTIC

Red Plaid High-Sided Box



<u>LEFT</u>: This **RED PLAID HIGH-SIDED** box has a very early doll standing in it.

RED PLAID boxes with "porthole" lids have been found with very early painted plastic dolls. Check your <u>FTLD</u> book on p. 79 for an example of a MIB black pair.

Not all dolls found in the RED PLAID box are ethyl cellulose plastic. "Ethyl Cellulose" is the name given to that brittle, easily shattered plastic, the plastic the company colored in an attempt to match skin tones. If you have an early doll and wonder about her, you should check each of the five pieces. If the doll parts are Coca-Cola colored, green or mottled pink, you probably do not have to worry. If the plastic is bubble-gum colored, you may well have an ethyl cellulose doll.

The HIGH-SIDED were used for the compo & painted plastic dolls. These HIGH boxes are a full inch taller & a full inch wider than later boxes. They came in at least four different paper patterns.

Garden Party

While going through my original pictures of Terri, most of which are in the *Fashion Parades* I came across this picture simply titled on the back "Garden Party".

The Terri pictured is of the 1950s vintage and looks lovely in this dress. Since we have never seen it I'm

assuming it is a porotype waiting to go into production. The last time a Garden Party dress was pictured was in the May 1954 Monthly Magazine, so could they have decided the above dress was too costly to make and settled on the last garden party dress we know?



The photo was haunting to me, I've seen it before just could remember where. When that happens it means it's time to reorganize the Terri Lee closet. And there was the dress in a Knickerbocker box. The box even had a copy of the photo glued to where the clothing description would be. While not the original from the 50's this dress is beautiful and would have been a nice addition to the 1956 *Fashion Parade* of outfits.

The dress has three rows of velvet trim sewn around the organdy dress and ties at the waist. There is also an attached organdy slip. The reproduction has vintage flowers sewn on the bodice coping the original and in a clear box is a bouquet to wear on Terri's wrist, flowers with beautiful ribbons to match the dress.

The Tip-Top Products Company of Omaha, Nebraska played an integral role for the Terri Lee Doll Company. Not only did they enter into contract to mold the doll parts within the first years of production they were the suppliers of metal rollers for the wiggers. As *Peggy Casper* reports in Chapter 3 of *Fashionable Terri Lee Dolls*, Ben H Myers, "Ben, your Hairdresser" experimented with a variety of materials for wigs and developed how the wigs were to be designed. Two sections: one for the shorter bangs and center back of the hair, the other section for the side sections. By 1950 when the coarse fiber had been completely replaced with finer fiber wigs they would be shipped to the doll company where the staff would secure the fiber sections to a board and then curl the fiber using the aluminum curlers supplied by Tip-Top Products Company of Omaha.



This first photo shows how the two sections would have been applied to the head. It would have been applied to a mesh base placed on the head and glued. After glue had dried than the curlers would be removed. The final step would be the finished styling, with a hairnet or snood to cover which would hold the hair in place until owned by a Little Mother.

Per Peggy Casper's first hand reports two or three curlers were used for the bangs and six for the center back then six for the side sections, three each side. Just like the factory wigs show on the photo at left using the contrasting hair colors as an example.

If you look carefully in Fashionable Terri Lee

on page 21 Illustration No. 32 it shows both the wig board and a box full of wigs.

Tip-Top Products Company of Omaha Nebraska provided for Terri Lee the molds for dolls, Curlers to set hair and the Hair Care Kits. Per a search of the company name I found that they received their Tip-Top trademark in 1948 and their products included: non-electric hair curlers, wave clips and bachelor buttons. Their trademark name expired in 1992. Mr. Carl Renstrom the company founder made his fortune upon an improved design from poorly made Germany curler called a "Ruck Zuck". Renstrom named his curler the Tip Top Easy Curler in 1936 which sold as four aluminum curlers on a card selling for ten cents a card. By 1964 he was selling more than 600 different products. He sold Tip-Top Products in 1964 to Rayette Co.

We collectors always seem to extend our collections with additional "go-with" accessories. Tip-Top is a great go-with not only because Terri Lee is pictured on the card that sold Tip-Top Curlers but because we can use them to re-curl our dolls hair. Several Tip-Tops sample products are shown here.







We have always looked to this building on the right located in Omaha with the water tower as the site where our curlers were made and

in fact this building only came into the Tip-Top land holdings in 1963.

It is my opinion there was another building used to produce the TL molds. It may have

been the building pictured below which was a location occupied by Tip-Top Products from 1948 until 1981 .







This was the Tip Top Products Division Fabrege' office. Located on Cuming Street from 1949 to 1981, the building was demolished in 2010.

SOLVING ANOTHER MARY JANE MYSTERY?

After reading Pat Rather's "The Almost Complete Mary Jane" I was convinced most of the mysteries of Mary Jane were solved. However, a few months ago I unearthed a new conundrum of sorts.

I had purchased a Mary Jane wearing an attractive plaid skirt and tam with a golden velvet Jacket. I was sure the skirt and tam were original because they matched a similar picture in the Mary Jane brochure (SWEATER GIRL 044). However in the brochure Mary Jane was wearing a sweater with the skirt and tam and not a gold velvet jacket. I was curious since the Mary Jane I purchased was advertised as having all tagged clothing.



When she arrived the first thing I did was to check the clothing to make sure it was tagged as advertised. Indeed all the clothing was tagged except for the gold velvet jacket. Instead of a Mary Jane tag the jacket tag read "Penny Walker".



Who was this Penny Walker? Was she a person or a doll? I contacted the dealers and they were surprised the jacket wasn't tagged Mary Jane. AND....they also had no idea who Penny Walker was.



Thus my search for Penny Walker began. I asked collectors. I asked dealers. I Googled Penny Walker doll and the doll that came up looked more like a baby doll than the slim body of Mary Jane. In some photos she was referred to as the Littlest Angel, a doll manufactured by the R &B Company. Could this be the end of my search? Who was Penny Walker?

I kept looking on eBay and searching on line until at last I found a doll called Penny Walker that was wearing what I was sure was a Mary Jane dress. This had to be the one. I had the identical dress with a Mary Jane tag. The dealer had to be wrong about the Penny Walker tag. If this Penny Walker doll was wearing a Mary Jane dress then the clothing had to be interchangeable and the gold velvet jacket my Mary Jane was wearing would fit a Penny Walker doll! This had to be the Penny Walker I was searching for.

I contacted the seller and she assured me this was a Penny Walker doll wearing a Penny Walker tagged dress. I just had to see for myself so I bought the doll. I congratulated myself for finding the Penny Walker doll. At least one problem was solved. But as Glenda Kitto reminded me, *One can find out the answer to one question and all it does is create more questions!*

My problem of finding the Penny Walker doll was solved but now I had what I thought were identical dresses each with a different label....Penny Walker and Mary Jane. Of course, it was obvious! The clothing was interchangeable and my new Penny Walker could wear Mary Jane clothing. Not so easy.... How wrong I was!!!!

When I received the Penny Walker doll I was astonished to find that the dress she was wearing **was** tagged Penny Walker! Furthermore the two dresses, although seemingly identical were not the same

size. One was definitely a bit smaller than the other. My hypothesis was proven wrong. It was not the same dress. Looked the same but definitely a different size and each with a different label.



So I'm left with more questions just as Glenda predicted. Did companies sell dress patterns? Did



they sell clothing so other companies could add their own labels? Were some dresses open market for dolls? I do know that Sue Nast did a presentation at the Salt Lake City Convention on Littlest Angel dolls in Terri Lee clothing. If this was Vi's way of keeping Terri Lee alive after the Apple Valley fire, did other companies do the same thing?

This still doesn't explain the dress in different sizes. Why would this one be copied? Certainly it's not that memorable or clever. I can understand the different labels being used but that doesn't explain

the different sizes. Any ideas?

To add to the conundrum the following advertisements were found dating the doll from 1953 to 1955. Mary Jane is used on a Penny Walker Doll Ad. OK, so when Vi sued and won her claim against Freydberg in 1954 was Penny Walker Mary Jane's successor? Maybe this was a reason why her clothing was being used by Penny Walker? Were they trying to salvage a piece of Mary Jane? Plus Penny Walker dolls are both 12 and 18 inch dolls and could easily wear Mary Jane or Terri Lee clothing!

I am open for all the help and additions collectors can add.



Taffeta Sunday School Dress

Just when you think you have all the examples that could be found for an outfit another comes along. It is a one of a kind, or was the dress put in the reject bin due to the flowers missing? This dress has no lace at the hem, no flowers and no rhinestones. But it is the Taffeta Sunday School Dress, I'm sure any "Little Mother" would have loved to dress her doll in. I need to change the below statement due to the in pictured Terri her Sunday School Dress.

This dress comes in four variations

- 1) Taffeta dress with rhinestone in the center of three daisy's
- 2) Taffeta dress with lace at the hem
- 3) Taffeta dress with lace at the hem and rhinestones on the bodice
- 4) Taffeta dress, plain

Snood (Head Accessory)

One of the first chapters of the Accessory Book printed contained an article on the Snood. Updated information has been found!

The **Snood** has been found listed on two different price lists: (Also in March 1956 Monthly Mag.)

- 1954 Catalog # 5911 for 10-cents each
- 1956 Catalog # 1843 for TL along with Catalog # 3843 for TTL







Several colors (blue, light blue, pink, silver and gold) have been found which is so typical of all the fashions for our Queen of Dolls.

A **snood** (/snu:d/) is historically a type of female headgear designed to hold the hair in a cloth or yarn bag. In the most common form, the

headgear resembles a close-fitting <u>hood</u> worn over the back of the head. It is similar to a <u>hairnet</u>, but snoods typically have a looser fit, a much coarser mesh, and noticeably thicker yarn. A tightermesh band may cover the forehead or crown, then run behind the ears, and under the nape of the neck. A sack of sorts dangles

from this band, covering and containing the fall of long hair gathered at the back. A snood sometimes was made of solid fabric, but more often of loosely knitted yarn or other net-like material. Historically (and in some cultures still in use today) a small bag of fine thread—netted, tatted, knitted, crocheted, or knotted (see macramé)— enclosed a bob of long hair on the back of the head or held it close to the nape. ¹



INSTRUCTIONS:

- 1. Cut 4 pieces of the pattern.
- 2. Taking two of the pieces at a time, with right sides together stitch a ¼" seam along curved edge.
- 3. With right sides together, stitch along curved edge from the bottom to the point top and back to the bottom.
- 4. Turn up a ¼" seam at the bottom and stitch in place.
- 5. Turn right side out. All done.
